PRESIDENT'S REPORT: Vice President Shores: No report

SECRETARY'S REPORT:

Secretary Figone: The minutes went out last week; I have had no feedback as far as corrections. Vice President Shores: Do we have a motion to accept the minutes as sent? TREASURER'S REPORT:

Treasurer Donovan: The ending balance we had for April was \$13,757.78. In May we took in \$386.00 of which \$175.00 was from membership, \$100.00 from 50/50, \$105.00 from T-shirt sales and \$6.00 from the sale of a VKA patch. That was the \$386.00. The cash going out was \$249.03, \$242.68 for printing, \$86.15 for postage, we received a refund on our Officer and Directors insurance of \$79.00, we are still with the same company but I gave the insurance to my brother, he refunded us the commission that he would have received. We have a ending balance for May of \$13,894.75. I felt very uncomfortable giving the insurance to a company that would not return phone calls or emails, which is why I gave it to my brother. Vice President Shores: I make a motion to accept the treasurer's report as read.

Director Figone: I second the motion.

Vice President Shores: All in favor of the motion say aye, opposed say nay, the ayes have it, the motion passes.

SAFETY REPORT:

Director Kossaras: Not much on safety except feedback I get from the members. I will be at New Castle. Someone brought up the issue of the overall kart width on a single sidewinder, we need to go to the WKA rule book for the era that we are talking about, I will look it up.

MEMBERSHIP REPORT:

Bill Bloodworth: The full membership is at 307, we have 47 associate members for a total of 354. The mailing rates are going to go up about a penny on the bulk rate, the rate to Canada went up five cents, to Australia it went up ten cents.
