PRESIDENT'S REPORT:

SECRETARY'S REPORT:

Secretary Figone: The minutes went out this morning, if there are no corrections can we have a motion to accept the minutes?

TREASURER'S REPORT:

Treasurer Donovan: This month I put the bank statement in the report which is what I will be doing in the future so we can see what the bank balance is and reconcile to the bank balance. The August beginning balance was \$13,398.65; our income for August was \$546.00 from membership, \$100.00 from the Quincy event and \$118.00 from T-shirt sales for a total of \$764.00 for the month of August.

Our expenses for August were \$64.02 for postage and \$66.01 for T-shirt sales, which was for shipping the T-shirts back and forth. Our ending balance for August is \$14,032.62, the bank statement shows \$14,013.62, a difference of \$19.00 which is the petty cash change I had which was deposited into the account in September, there is no more petty cash on hand. The T-shirt sale at Fremont was zero.

I sent 20 shirts to Greg to sell at Bakersfield.

Director Wlodarsky: I make a motion to accept the treasurer's report as is.

Director McCornack: I second the motion.

Secretary Figone: The motion has been made and seconded, all in favor say aye, opposed say nay, the ayes are unanimous, the motion passes, thank you.

SAFETY REPORT:
